YALO Closes Q2 2025 with Growth, Innovation, and Strategic Expansion

YALO wrapped up Q2 2025 with strong momentum, achieving 12,000 users and 74 active B2B partners. A major highlight was the launch of its staff housing program, which has already supported 67 employees.

The team deepened user engagement through its "Rent on the Go" community pop-up series and is preparing for the upcoming launch of the YALO Marketplace.

Argentil continues to support YALO's growth journey, including the company's N1 billion debt raise for on-lending. As of Q2 2025, YALO has successfully secured over N600 million to provide rental finance solutions for young professionals across Nigeria.

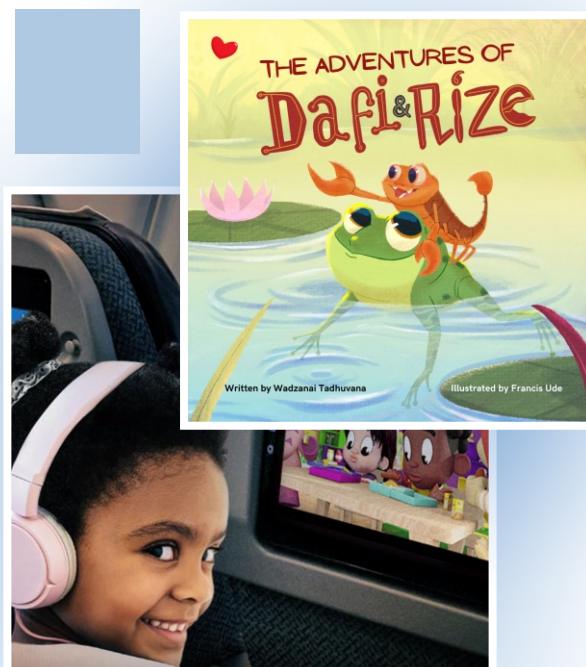


3 Kunda Kids launches in the Air!

Kunda Kids continued 2025 with impressive growth across its key businesses. A major highlight was securing its first in-flight entertainment deal select episodes of Kunda & Friends are now available on a major international airline, marking an exciting step toward global distribution.

Its flagship animation show, Kunda & Friends, has reached ~120,000 subscribers and over 52 million views. The newly launched French-language channel is also off to a strong start, already surpassing 1 million views and gaining over 8,000 subscribers.

In a major milestone for educational impact, Kunda Kids also launched a new literacy initiative in partnership with the Bill & Melinda Gates Foundation.



4 FMGSL Natural Gas Plant on Track for 2026 Launch

First Modular Gas System Limited (FMGSL) is making strong strides in the development of its 5mmscf/d gas processing plant located in Abia State. The project is a critical part of Argentil's effort to support Nigeria's use of gas as a transition fuel to improve access to cleaner and reliable energy.

On completion the project will supply Compressed Natural Gas (CNG) and Liquified Petroleum Gas (LPG) to ensure cleaner energy availability to over 10 million people in the region. It is expected that the total phase I development of 15mmscf/d will:

- Displace up to 237,140 tonnes per year of CO₂ emissions
- Replace 129 million litres of diesel for power generation
- Leading to reduction of 111,884 tonnes of CO₂ emissions

The plant will be commissioned in Q2 2026.
